# General Club Rules Tennis

#### a. COURT ETIQUETTE

All members, guests, volunteers and staff of the North Bay Curling and Athletic Corporation (NBCAC) must conduct themselves in a courteous, respectful, and polite manner when dealing with other members, guests, volunteers, and staff of the NBCAC, both on the courts, in the clubhouse and on facility grounds.

- Yelling, profanity and the throwing of racquets will NOT be tolerated.
- Players must walk behind the courts and retrieve balls from other courts only during stoppages of play.
- Out of courtesy to other players, cell phones and music players should be turned off or silenced.
- Players must remove any garbage, food, drinks, clothes, towels, cans, and balls from the courts when they leave to ensure a safe and clean environment.
- Players should present a neat appearance. Tennis shoes are required for both safety and the preservation of the court surface. All players are to always wear shirts while on club grounds.

#### **b. MEMBERS**

Members must sign the NBCAC 'Participant Liability Waiver' and 'COVID-19 Declaration of Compliance' and pay all fees in full before courts can be booked.

## c. CLUBHOUSE

Inline skates, skateboards, and smoking ARE NOT permitted in the clubhouse or on facility property. Behind the clubhouse desk and office are OFF LIMITS to everyone except for the NBCAC staff and the current Board of Directors.

#### d. LIABILITY FOR LOST AND STOLEN PROPERTY AND INJURY POLICY

The NBCAC is not responsible for lost, misplaced, or stolen items OR for members or guests incurring injury while in the clubhouse or on facility property. Please lock your bicycles and keep your personal property with you at all times.

#### e. GUESTS

All guests must register at the clubhouse before participating in activity. The guest fee must be paid, and the NBCAC 'Participant Liability Waiver' and 'COVID-19 Declaration of Compliance' is to be completed.

#### f. CHILD SUPERVISION

Children are supervised by tennis instructors when taking lessons or during summer camps. During all other times, the supervision and safety of children is the responsibility of their parent and/or guardian.

## g. ALCOHOL, SMOKING, ILLEGAL DRUGS & CANNABIS

The consumption of alcohol on facility grounds is prohibited unless the alcohol has been bought by the NBCAC under a Special Occasion Permit, for the and only in the designated licensed areas.

- Smoking, illegal drugs, and use of cannabis is prohibited on facility grounds as per the *Smoke-Free Ontario Act, 2017. (Smoke-Free Ontario Act, 2017, S.O. 2017, c. 26, Sched. 3)*
- If the NBCAC staff believes a member is under the influence of either alcohol, illegal drugs, or cannabis, that member will be asked to leave the facility grounds immediately.
